When you browse our website www.pathe.be or on our Application, cookies are placed on your smartphone, tablet, or computer.

1. What Is a Cookie or Similar Technology?

A cookie is a tracker that gathers information about your browsing activity on our site.

There are two types of cookies:

- **Necessary or Essential Cookies:** These are cookies that assist or enable your navigation on the websites. Commonly referred to as technical or functional cookies, they are strictly necessary to ensure that the site you are browsing is operational. In accordance with applicable laws, necessary cookies are placed and read by Pathé without requiring user consent. These cookies cannot be disabled via the cookie consent banner provided by Didomi.
- **Non-Necessary or Non-Essential Cookies:** These cookies neither affect the quality of your browsing experience nor the site's basic functionalities. However, these cookies are always placed and read by Pathé and its partners only with your explicit consent. You are free to enable or disable them. There are two types of non-necessary or non-essential cookies:
 - o Audience Measurement/Performance Cookies
 - o Advertising Cookies

Non-necessary cookies offer several benefits for you:

- They make your browsing experience more user-friendly and personalized through displays and content tailored to your expectations.
- They enable Pathé to offer you advertisements tailored to your preferences on our website or those of our partners (advertising cookies).
- They facilitate interactions with your social media platforms (social media cookies).
- They optimize your experience on our site by providing precise traffic metrics (audience measurement cookies).

d) Privacy Policy of Partners

Regarding cookies such as Google Analytics, TikTok, Google Advertising Products, Google Tag Manager, Facebook, Auth0 : these cookies are subject to user consent. However, since Pathé cannot guarantee absolute control over the reuse of data by these platforms, Pathé has chosen to implement a tool (Addingwell) that obfuscates the last two digits of collected IP addresses before transferring them to the aforementioned platforms.

Cookies are placed either by Pathé or by third parties based on the choices you made during your initial cookie consent settings when visiting our websites or using our applications for the first time.
